Annual Meeting Report


The AFA held its annual meeting on Nov. 16th at Olmstead Manor in Ludlow. Election of officers included Amanda Hetrick as President, Bob Kirchner as Vice President, Becky Lucia continuing as Secretary, and Ed Sleeman re-elected as Treasurer. Five at-large board seats were all re-elected.

Andrea Hille, ANF Forest Silviculturist, was the guest speaker and gave an excellent presentation on the Forest Health Collaborative. She also answered questions from the audience related to forest health and management issues. Ms. Hille shared that she expects an increase in harvest volume on the ANF in 2017/2018, and that the 2016/2017 receipt should reflect an increase as well.

Lest We Forget...

"And now, first and foremost, you can never afford to forget for one moment what is the objective of our forest policy. That objective is not to preserve the forests because they are beautiful, though that is good in itself; nor because they are refuges for wild creatures for the wilderness, though that, too, is good in itself; but the primary object of our forest policy in the United States, is the making of prosperous homes. Every other consideration ---Theodore Roosevelt comes secondary."

This quote, from the President who created some 2 mil-

lion acres of national forests, reserves and refuges, aligns with the AFA's purpose. We too believe that the beauty of the forest is important, and that preservation of limited sections is valuable. We too believe that managing the forest to support habitat for wildlife is important. But, most of all, the ANF should support healthy communities by providing funding for its host communities and jobs for its residents.

Pine Bear Supplemental EA (updated): Forest Products, Vegetation

Threats Identified

The Forest Health Collaborative group identified eight threats on the ANF:

- Age Class Imbalance
- Emerald Ash Borer
- Safety & Esthetics
- Loss of Forest Diversity
- Loss of Hemlock Species
- Black Cherry Defoliation and Decreased Reproduction
- Non-Native Diseases
- Non-Native Plants

Strategies were identified and prioritized by the group, with a composite strategy created to address:

- Sustaining Resilience
- Black Cherry Sustainability
- **Rapid Response Approaches**
- Integrated Pest Management
- **Restoring Impacted Ecosystems**
- Monitoring
- Hazard Tree Removal on Roads
- Prioritizing Remaining Areas
- Assisting Private Landowners

The Collaborative will re-convene annually to share information, discuss trends and observations, treatments, research, and strategies.
