National EADM Report—Results of Nationwide Partner Roundtables

The Forest Service has launched an Agency-wide effort to improve processes related to EADM with a goal of getting more done through better efficiency and reducing the time and cost associated with EADM processes.

The goal is not to avoid laws, regulations, policies, or science-based environmental analysis in stewardship of the land. Nor is this a new effort; the USFS has explored improvement to EADM processes for over thirty years.

Regional EADM Partner roundtables were held nationwide in Feb./Mar. 2018 to collect partner feedback. The message heard across the country is that the agency must first move away from risk aversion and fear of litigation, and truly em-

brace partnerships and collaboration across all levels of the Agency. They must also move away from the "culture of mobility" in which USFS incentivizes frequent employee movement for career advancement. This culture has long been recognized locally as interfering with EADM, community relationships, and an understanding of local ecological and socioeconomic conditions.

As a result of this roundtable, the USFS aims to decrease cost and increase efficiency of EADM processes by 20% by 2019.

Knox-Kane Trail—"Now What?"

At a June 15th meeting in Marienville, Forest County, a large group gathered to discuss the status of the Knox-Kane Rail Trail and the opportunities the trail will provide for our communities.

As a recreation project that runs through the Allegheny National Forest, the AFA had an interest and was represented by our president, Amanda Hetrick. AFA board member Tom Kase was a presenter.

Discussion throughout the day-long event included topics such as business opportunities, trail infrastructure and visitor amenities, Greenway Plans, invasive plant management, health benefits of trails, and bike route connectivity.

Jenks Township Supervisors (Forest County) have secured several grants to establish a trail hub at the old Marienville train station. These include \$500,000 from DCNR, \$1.1 million from PennDOT, and \$67,000 from ARC. Uses will include trail construction, parking, pavilion, restrooms, and an information center.

Buckthorn-It's Here, Prolific and Persistent

The Buckthorn is an exotic, invasive shrub that becomes the dominant species in the understory and can form dense, continuous canopies up to twenty feet thick, shading-out its competitors. It is highly tolerant of shade and wet sites, seeds prolifically, and stump sprouts (see photo below of 11-monthold log with sprout), making it hard to kill. It was introduced in the late 1800s for windbreak and wildlife plantings.

In a 200-2004 Michigan State University study in Upper Michigan, using cutting and glyphosate application prior to clearcutting the parent aspen showed promising results: aspen sprout density of 25,000/acre was dominating the buckthorn. The commercial cost for this control method was \$150—\$200 per acre.



There's hope that this method will prove successful in our region as well. Buckthorn is on the ANF and a threat to the density and diversity of native species.

Park vs Forest

The AFA continues to work to informing the public about the Allegheny National Park Campaign and how it will do more harm than good—and to mobilize those who oppose the concept.

- A page added to our website with concerns and facts regarding how National Park designation would effect the ANF and our communities.
- Distribution of "NO Allegheny National Park" stickers to make more people aware and direct them to the AFA website.
- Development of "NO Allegheny National Park" merchandise to help build awareness and help the AFA fund its opposition campaign.
- Development and distribution of informational brochures with concerns and facts, and how you can help the AFA opposition effort.
